

## **Privacy Statement**

Med-Pak, A Division of Self Seal Container Corporation is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Med-Pak, A Division of Self Seal Container Corporation Web site and governs data collection and usage. By using the Med-Pak, A Division of Self Seal Container Corporation website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

Med-Pak, A Division of Self Seal Container Corporation collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number.
